Helen, how do these laws you cite apply to my request?

RS 44:1(A)(2)(a) All books, records, writings, accounts, letters and letter books, maps, drawings, photographs, cards, tapes, recordings, memoranda, and papers, and all copies, duplicates, photographs, including microfilm, or other reproductions thereof, or any other documentary materials, regardless of physical form or characteristics, including information contained in electronic data processing equipment, having been used, being in use, or prepared, possessed, or retained for use in the conduct, transaction, or performance of any business, transaction, work, duty, or function which was conducted, transacted, or performed by or under the authority of the constitution or laws of this state, or by or under the authority of any ordinance, regulation, mandate, or order of any public body or concerning the receipt or payment of any money received or paid by or under the authority of the constitution or the laws of this state, are "public records", except as otherwise provided in this Chapter or the Constitution of Louisiana.

LSA-Const. Art. 1, Sec. 5 - Right to Privacy - Every person shall be secure in his person, property, communications, houses, papers, and effects against unreasonable searches, seizures, or invasions of privacy. No warrant shall issue without probable cause supported by oath or affirmation, and particularly describing the place to be searched, the persons or things to be seized, and the lawful purpose or reason for the search. Any person adversely affected by a search or seizure conducted in violation of this Section shall have standing to raise its illegality in the appropriate court.

Hey, Helen, sorry it took a while to get back to you.

Just to be clear, I will take this latest response, "no documents exist that are responsive to that request," as applicable to both my first request for the letter and also my subsequent request for a letter with the specific keywords. Is that your position?

I'm not sure if you are aware, but The Current was recently successful in its public records lawsuit seeking documents related to the termination of interim Lafayette Police Chief Wayne Griffin. Among the records the judge ordered to be released was a redacted version of the termination letter, which is what I am seeking here.

LCG, as you did in your response, also cited Trahan, which pertains to employee evaluations, so I don't see its applicability. The East Bank case appears to relate to personnel files, which is not what I am requesting, though any termination letter would certainly be part of that file. Courts have held: "Whenever there is doubt as to whether the public has the right of access to certain records, the doubt must be resolved in favor of the public's right to see. To allow otherwise would be an improper and arbitrary restriction on the public's constitutional rights." Given that, I can certainly imagine a judge determining that a disciplinary letter or termination letter related to an embattled mayorpresident would be a public record. To be clear, we are not planning to pursue any legal action on this matter.

I just thought a response, belated as is, was due.

Art. 1, Sec. 5. See also, Trahan v. Larivee and East Bank Consolidated Special Service Fire Protection District v. Crossen.
