
Based upon the agreement of the parties to this public records action, as evidenced by their signatures below,


IT IS ORDERED, ADJUDGED AND DECREED


SATISFACTION OF JUDGMENT

- 3) There is no need to file the Consent Judgment or this Satisfaction of Judgment in the mortgage records of the Lafayette Parish Clerk of Court.


